v. Terms and conditions:

- It is mutually understood and agreed by and between **Udaynarayanpur Madhabilata Mahavidyalaya** and **George Telegraph School of Skills**, A: 31A, S.P. Mukherjee Road, Kolkata -25, that the MoU will remain effective for 3 (Three) years. The MoU may be extended or revised after every 3 (Three) years on mutual discussion between the two Institutes viz. **Udaynarayanpur Madhabilata Mahavidyalaya** and George Telegraph School of Skills, A: 31A, S.P. Mukherjee Road, Kolkata 31A, S.P. Mukherjee Road, Kolkata. Awareness and Seminars would be conducted as and when required, either at **Udaynarayanpur Madhabilata Mahavidyalaya at Udaynarayanpur** or George Telegraph School of Skills, A: 31A, S.P. Mukherjee Road, Kolkata -25 or both places, on the basis of mutual consent. The MoU may be extended or revised after every 3 (Three) years on mutual discussion between the two Institutes viz. **Udaynarayanpur Madhabilata Mahavidyalaya** and George Telegraph School of Skills, A: 31A, S.P. Mukherjee Road. Kolkata.
- This MoU shall be governed and construed according to the laws of the country for each participating party. Any dispute will jointly be resolved involving the Principal of **Udaynarayanpur Madhabilata Mahavidyalaya** and the George Telegraph School of Skills, A: 31A, S.P. Mukherjee Road Kolkata, in a spirit of independence, mutual respect, and shared responsibility.
- The MoU may be terminated by either party after giving a notice of six months (180 days) provided that this clause will be operative only if either party violates the terms of MoU or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or change in constituting parties.

VI. Confidentiality:

Both the parties shall maintain in confidence and safeguard all information that the each party may come to know as a result of this Agreement.

XI. Entire Agreement - Execution and Modification

This Agreement wholly cancels, terminates and supersedes any and all previous agreements, negotiations, commitments and writings between the Parties in connection with the subject matter of this Agreement.
